Chairman of the Board, Paul Joly called the meeting to order.

Present: Paul Joly, Clerk of the Board of Commissioners, Patrick Menges and Sue Medeiros.

Pledge of Allegiance.

Patrick Menges as Clerk of the Board said, "Let the record show Board of Commissioners, on August 9th voted to hold a public hearing on the included in District or excluded from District status of streets in the Town Hall Lower Level at 2:00 P.M., 10 September that at that hearing the name of each street be read out and all public comments on the status of each street be recorded, that a map of the streets in Town be present and that general comments and questions follow and that then the Board take the whole matter under advisement for final resolution of any issues raised and forward the results approved by the Board to our surveyor and the Board of Assessors.

Handouts were given and reviewed.

Patrick Menges read off a list of streets. Patrick Menges VOTED; Mr. Chairman I make a motion that the Board of Commissioners enroll for the record the list I have read of the streets and parts of streets in the 1950 District, parts of streets being those streets included in the area map within the boundaries description in Section 1 of Chapter 359 of the Acts of 1950, seconded, Sue Medeiros, all were in favor.

Patrick Menges read off a list of streets with no water service. Patrick Menges VOTED; Mr. Chairman I make a motion that this list as read within the inclusion of Audrey Lane and Tiger Lily Road of streets without water service be adopted as the conclusive list of streets be excluded from the District because they are outside our service area, seconded, Sue Medeiros, all were in favor.

Patrick Menges read off a list of streets petition accepted by the District serviced not in the District. Patrick Menges VOTED; Mr. Chairman I make a motion that the list that I have completed and read delineating the streets petitioned into the District serviced but not in the District and serviced but not in the District be accepted, seconded, Sue Medeiros, all were in favor. Patrick Menges Voted; At this time I move that the list we have just read with the statuses of the streets that I have just enrolled be accepted by the Board for transmission of the Board of Assessors, the Surveyor, the Board of Registrar and our Counsel and as testification here of I as Clerk of the Board am going to sign it first and I'm going to ask Commissioner Medeiros, and Joly sign it also, seconded, Sue Medeiros, all were in favor.

Sue Medeiros mentioned questions would be addressed to District Counsel.

Patrick Menges read Chapter 359 Section 7.

Sue Medeiros VOTED; Motion to adjourn at 4:15 P.M., seconded Patrick Menges, all were in favor.
